



## KIMS TO GET ANOTHER LMO

Hospital has 20-kilo-litre LMO unit, from which oxygen is supplied to Covid and C

AS the number of Severe Acute Respiratory Infection (SARI) cases increases in Dharwad district, KIMS hospital has decided to install one more Liquid Medical Oxygen (LMO) unit in the hospital premises in Hubballi.

Most of the SARI cases from the district are being shifted to KIMS hospital. Even critical cases from neighbouring districts including Belagavi, Ballari, Bagalkot are being shifted to KIMS. The hospital increased the number of beds from 250 to 600 recently.

The hospital has a 20-kilo-litre LMO unit in its premises from which oxygen is being supplied to Covid and general wards of the hospital. But these days as the number of patients with respiratory issues has increased, the present LMO unit is fully functioning and if the number of patients increases further, the hospital may face a shortage of oxygen supply.

Dr Ramalingappa Antaratani, director of KIMS hospital said, "is a large consumption of oxygen in the hospital and liquid oxygen is very cost-effective and convenient to supply. Oxy-

gen cylinders will not fulfil the increasing demand. "Once the new unit is installed and begins functioning, KIMS hospital will have a total 40 kl oxygen supply which will help to treat more patients," he added.

The government is spending Rs 50 lakh for the installation and maintenance of the unit for a decade and the work order has been given to Praxair, an industrial gas company. The company will soon start LMO unit installation work and it will maintain the unit for 10 years.

PEOPLE in the district are irked with the authorities for their dual stand in connection with penalising violators. The administration, on one hand is implementing strict rules and regulations with regard to Covid, and on the other, is failing to provide facilities.
